Dear CCW Applicant,

Congratulations, the Sheriff's review of your application for a Concealed Carry Weapon License is complete!

PLEASE READ AND FOLLOW THE GUIDANCE CONTAINED IN THIS MEMO REGARDING THE FINAL STAGES OF LICENSING. FAILURE TO DO SO WILL DELAY PROCESSING OF YOUR APPLICATION.

FIREARMS:

- All firearms must be registered specifically to the licensee in the state of California.
- You may have a maximum of three (3) firearms on your license.
- You may change the firearms listed on your license **prior** to attending a certification course. Email make, model, caliber and serial number to the CCW Unit at sheriffs CCW@smcgov.org.

QUALIFICATIONS:

- Schedule a California CCW training course with one of the San Mateo County Sheriff's Office approved training vendors; see the list included on page 2 of this memo. All fees and associated costs are the responsibility of the applicant.
- CCW license holders are mandated by California state law to attend a firearm safety course.
- Individuals are also required to qualify with *each* firearm listed on their CCW application under the direction of a qualified range instructor.
- Your application must be approved by the Sheriff's Office **prior** to attending a training class and your certificate must be dated **after** your approval notification.
- To avoid issuance delays, it is your responsibility to provide and confirm the correct make, model and serial number for all firearms listed on your qualification certificate.

SUBMISSION OF CREDENTIALS:

- Qualification certificates must be submitted within 120 days of approval.
- **Email** your certificate of completion to Sheriffs_CCW@smcgov.org. This assures your 'place in line' as we book pick-up appointments in chronological order of submission.
